COLLEGES - Unaided Colleges - Permission to open a Self-Financing College in the name of Dhanalakshmi Srinivasan College of Arts and Science for Women, Perambalur by Dhanalakshmi Srinivasan Charitable and Educational Trust, Perambalur during 1996-97 - Orders Issued.

ORDER:

The Commissioner of Collegiate Education has forwarded the application submitted by the Dhanalakshmi Srinivasan Charitable and Educational Trust, Perambalur to open a Self-Financing private college in the name of Dhanalakshmi Srinivasan College of Arts and Science for Women, Perambalur, Perambalur Thiruvalluvar District. The Commissioner of Collegiate Education has stated that the management has provided the following:

i) An Endowment of Rs.10/-lakh (Rupees Ten lakhs only) has been created in the joint names of Commissioner of Collegiate Education and the Trust. Rs.5 lakhs is remitted in Tamil Nadu Transport Development Finance Corporation Limited on 16.2.96 and Rs.5 lakhs is remitted in Union Bank of India, Valikandapuram, Trichy on 25.3.96.

ii) The Management has acquired 5.61 acres of land at Perambalur in the name of the Trust through registered gift deed in S.No.464/7, 464/9, 464/10, 464/11, 448/1, 448/2, 448/5A, 448/6 and 448/8 (Total 5.61 acres).

iii) Agreement in stamp paper to abide by all conditions prescribed by the Government.

2. The Government have examined the proposal carefully and they permit the Dhanalakshmi Srinivasan Charitable and Educational Trust, Perambalur to open a Self-financing Women's College in the name and style of Dhanalakshmi Srinivasan College of Arts and Science for Women at Perambalur during 1996-97 with the following courses:

- (1) B.Sc. Maths.
- (2) B.Sc. Physics.
- (3) B.Sc. Chemistry
- (4) B.Com.

3. The management is permitted to start the College during 1996-97 temporarily in the existing building at the Matriculation School owned by the Trust, and it should be shifted to the permanent building during 1997-98 to be constructed in the land mentioned in para 1 (ii) above.

4. The permission granted in para 2 above is also subject to the following conditions:

(1) Affiliation from the Bharathidasan University, Trichy should be obtained for the college from the year 1996-97 and before the commencement of all courses of study.

(2) The land mentioned in para 1 (ii) above should not be utilised for any purpose other than college purpose.

(3) The Government will not grant any financial assistance at any time.

(4) The management should satisfy all the conditions prescribed in G.O.Ms.No.858, Education, dt.15.7.89.

(5) No, other courses of study except science Arts and Commerce courses, allowed by the Government/University should be conducted.

(6) The teaching and non teaching staff shall be appointed as per the yardstick and they should possess the prescribed qualifications.

(7) If the management creates a situation causing the closure of the College for any reasons, the Government will not come forward to take over.

5. The Government also condone the delay on the part of the Management in submitting the application as well as in creating the endowments for opening of the College.
